

# Parent Agreement

Note: Required by the Little League of the Islips, this agreement MUST be read, agreed to and signed on the front side of this form, by the parent or guardian, of any registered player in this Little League. Failure to do so will result in the nullification of any current or new registration.

**1. CONDUCT:** As the parent or guardian of any child participating in the Little League of the Islips, I agree to conduct myself in a civil manner, at all times, while on any Little League authorized complex. I also agree to abide by the rules set down by this Little League that are in effect now or in the future. While I am on the Little League complex I agree to NO alcoholic beverages, NO PETS, NO SMOKING, NO bicycle riding, NO littering, and NO destruction of Little League grounds or property. I will conduct myself in a courteous manner and refrain from abusive language towards players, umpires, coaches, the volunteers, league officials, or other spectators. I understand that if I have a grievance, I may present it to the Board of Directors in person or in writing. I also agree to abide by the directions of persons authorized, by the Islip Little League, who are entrusted with enforcing the rules and the regulations of this complex and the safety of the players. I further agree to any vehicle parking regulations set forth by this league including NOT blocking emergency exits, NOT blocking in other vehicles, and driving in a safe defensive manner. I understand that a failure to abide by these rules can result in my expulsion from the complex and possible suspension from the grounds.

**2. Equipment:** I understand that any equipment and uniforms issued by the Little League of the Islips is the property of this league and should be maintained in a suitable manner, used only in accordance with Little League purposes. I agree that any equipment and uniform that is lost or destroyed (other than reasonable use) I will compensate the Little League of the Islips in a monetary amount set forth by this league.

**3. Insurance:** I understand that the Little League insurance coverage applies only to registered players, volunteers, and officials of the Little League of the Islips. That this insurance is secondary coverage which can only be utilized after your personal family insurance policy has been exhausted. That Little League insurance does NOT cover personal property, vehicles, spectators, or persons not authorized to participate in Little League events. I also understand that any injuries suffered by a registered player, while participating in a Little League event, must be reported in a timely manner to the league official responsible for collecting this information. All injuries must be brought to the attention of the team manager and an Accident Report must be submitted. League insurance applies ONLY to officially sanctioned Little League events on authorized playing or practice fields and in designated areas. Any and all practices held off the Little League complex or not within designated time periods must have prior approval by the Board of Directors.

**4. League Liability:** I understand and agree that the Little League of the Islips is NOT responsible or liable for personal property, which includes damage to vehicles. That the Little League of the Islips is NOT responsible or liable for injuries or damage which occur during non-sanctioned events, such as, parties, picnics, and unscheduled games or unauthorized practices.

**5. REFUNDS:** I understand that registration fees can only be refunded prior to the first official game of the season. That any parent requesting a refund must notify their team manager, who in turn must request a refund of the League Treasurer. No refunds will be issued until it is ascertained that all uniforms and equipment are returned in good condition. Refunds DO NOT include any expenditures made by the parent for uniforms, clothing, or equipment. **IT IS SUGGESTED THAT YOU BACK UP THIS REQUEST WITH AN E-MAIL TO: [IslipLittleLeague@gmail.com](mailto:IslipLittleLeague@gmail.com) TO ASSURE YOUR INFORMATION FOR A REFUND WAS RECEIVED.**

**6. Player Information:** As the parent/legal guardian, the information that I provide on the registration form as to any child's date of birth and residency are true. I also will provide information concerning my child's medical condition to the responsible officials when deemed necessary. My child is in good health and has my permission to enroll and participate. My child has no previous sickness, illness, disease or bodily injury which is in any way a constraint or restriction to their participation.

**7. Manager/Coaches/Umpires Appointments:** I understand that no manager, coach or umpire has tenure. If I am re-appointed or re-approved I will be contacted. If I am not re-appointed or re-approved, I understand that per Little League International, no reason will be given. ALSO-All Managers, Coaches Umpires and Volunteers are required to completely fill out a "Volunteer" form every year, once approved, as required by Little League International. Refusal to submit a volunteer form or submitting an incomplete form, said person, cannot participate as a Manager, Coach, Umpire or Volunteer. Little League International requires all volunteer names submitted to Little League itself for insurance reasons. Names will not be submitted unless the "volunteer" form is filled out completely."

## To All Parents, Coaches and Players

ALL players in the Baseball 8-year old, Minors (9-11), Majors (10-12), Juniors (13-14) and Seniors (15-16) divisions and ALL players in Softball Minors (9-10), Softball Majors (11-12) ARE SUBJECT TO THE DRAFT.

An approved manager and coach may use a draft "option" to reserve the right to draft their children. Details on exact draft procedures will be provided to managers and coaches prior to the draft.

**IN THE EVENT OF UNFORESEEN PROBLEMS, THE LEAGUE HAS THE RIGHT AND THE OBLIGATION TO PLACE PLAYERS ON ANY TEAM OR IN ANY DIVISION IT FEELS TO BE APPROPRIATE.**

**BIRTH CERTIFICATES:** Attach a copy of each child's birth certificate ONLY if the child was NOT registered last season.

**PARENTS AGREEMENT:** See above notes 1-7.

**SCHOOL:** Enter the name of the specific school each child will be attending in the 20/21 school year.

**TEAM & DIVISION:** Enter this information only if you remember. Divisions are:

**Baseball:** 8 year olds, Minors, Majors, Seniors. **Softball:** 6-8 year olds, Minor, Major, Seniors.
